COURSE DESCRIPTION:

The Fast-Track Teacher Preparation Program for Blended Instruction is a competency-based, micro-credentialed program designed to equip teachers with skill sets in implementing blended and online instruction, integrating technology for student engagement and self-directed learning, creating digital content, and incorporating Open Educational Resources (OER) into existing curriculum. The program is comprised of four micro-credentials, each meeting ADDIE requirements of *Analyze, Design and Develop, Implement, and Evaluate*. Content is delivered via

live and recorded webinars, on-demand videos and podcasts, and supplemental reading material.

The four micro-credentials include Introduction to Blended Instruction, Best Practices in Blended Instruction, Creating Digital Content, and Introduction to OER (optional micro-credential, which provides educators access to some of iLC's student course templates from its Digital Content Warehouse repository).

STUDENT LEARNING OUTCOMES:

Upon completion of this course, students will be able to:

1. Implement blended instruction using one or more models: Flex, A La Carte, Enriched Virtual, Flipped, Station Rotation
2. Integrate technology for student engagement and self-directed learning
3. Design, develop, and deliver digital content
4. Integrate Open Educational Resources (OER) into existing curriculum

COURSE REQUIREMENTS:

In order to receive a Passing grade (earning *Demonstrated* in all ADDIE requirements), the participant must complete the following course requirement:

- Assignments: Assignments require students to apply session content to current blended practices, developing digital learning activities for classroom implementation. Assignments are structured according to the ADDIE guidelines of *Analyze, Design and Develop, Implement, and Evaluate*. Participants are expected to reflect deeply on their learning experiences and observations.

COMPETENCY/UNIT THREE: Creating Digital Content

- Review myriad strategies and tools for digitizing curriculum
- Design and develop a lesson that includes digitized content
- Deliver the lesson
- Reflect on the learning experience

COMPETENCY/UNIT FOUR: Introduction to OER - For those who would like access to some of iLC's student course templates from its Digital Content Warehouse (DCW)

- Understand the purpose of using OER
- Review and determine which OER materials are relevant
- Examine best practices for integrating OER materials into existing curriculum
- Design and develop a lesson that utilizes OER
- Deliver the lesson
- Reflect on the learning experience
